#### **Notes**

#### FORM OF PROXY

- 1. As a member of the Company you are entitled to appoint a proxy or proxies to exercise all or any of your rights to attend, speak and vote at a general meeting of the Company. You can only appoint a proxy using the procedures set out in these notes.
- 2. Appointment of a proxy does not preclude you from attending the meeting and voting in person. If you have appointed a proxy and attend the meeting in person, your proxy appointment will automatically be terminated.

#### APPOINTMENT

- 3. A proxy does not need to be a member of the Company but must attend the meeting in person to represent you or be able to vote for you on Zoom. If you wish to appoint a proxy other than the Chair of the meeting, delete the phrase "the Chair of the meeting or" and insert in the box the full name of the person you wish to be your proxy. If you leave this space blank, the Chair of the meeting will be appointed your proxy.
- 4. Where you appoint as your proxy someone other than the Chair of the meeting, you are responsible for ensuring that they attend the meeting either in person or by Zoom and are aware of your voting intentions. If attending by Zoom, your proxy must register at <a href="https://www.arksynagogue.org/agmzoom">www.arksynagogue.org/agmzoom</a>.

If you wish your proxy to make any comments on your behalf, you will need to appoint someone other than the Chair of the meeting and give them the relevant instructions directly.

- 9. For an electronic proxy appointment to be valid, your appointment must be received by the **Board Secretary** no later than **10.30 am on 3 December 2024**.
